# **API HERB** Complementary feed for bees

# (Technical data sheet)

### FEATURES:

ApiHerb is a complementary feed in powder for honeybees; it should be dissolved in sugary syrup in the indicated doses and administered trickled inside the hive to bees. Its composition, based on officinal herbs, is designed to keep the digestive system of bees efficient.

#### INGREDIENTS:

25-50% Dextrose,
25-50% Garlic (*Allium sativum*) powder,
1-5% Cinnamon (*Cinnamomum zeylanicum*) powder,
1-5% Thyme flavour (*Thymus vulgaris* oil),
1-5% Mint flavour (*Mentha arvensis* oil),
<1% vitamin B1,</li>
<1% Vitamin B2,</li>
<1% Vitamin B6.</li>

No genetically modified organisms (GMO free):

The ingredients is derived exclusively from free GMO, which has not undergone any kind of genetic engineering treatment, in reference to the EC Regulations 1829/2003 and 1830/2003.

### DOSAGE, ROUTE AND METHOD OF ADMINISTRATION:

Mix 40g of the product in 500 ml of sugar syrup (water sucrose ratio 1:1). This suspension is the right dosage for the treatment (1 time) of 10 beehives. Drip 5 ml of this suspension for each comb inside the hive, (50 ml for beehives with 10 combs). We suggest preparing the product 12 hours before the use; keeping it in a cool place until the moment of the product use; do not use this suspension longer 48 hours from the moment of the preparation. Repeat the use for 3 times (one for week) in the springtime and in the fall time with temperature more of 10°C.

**PRODUCT VALIDITY:** The product maintains its characteristics unchanged for at least 24 months from the production date if stored in original closed packages, in a covered warehouse and at room temperature.
